

A.R.I. STANDARD INTERNATIONAL WARRANTY

TEN YEAR

Limited Warranty

This is a Ten Year limited warranty issued by **A.R.I FLOW CONTROL ACCESSORIES LTD.**, ("ARI") covering ARI's Special **RP 500 DC 500 Body** ("Product"). This warranty is non-transferable and applies only to the Original Purchaser and only to its Original Location of installation. When purchased from and properly installed by an ARI Authorized Representative and used appropriately and maintained appropriately, ARI warrants this Product against breakage under normal use for a period of Ten Years from the product having left ARI's premises and subject to receipt by ARI or its Authorized Representative, of written notice thereof within 30 days of discovery of such defect or failure ("**Warranty Period**").

It is the Original Purchaser's responsibility to protect the Product in accordance with the instructions provided by ARI's.

EXCLUSIONS & LIABILITY LIMITATIONS

If a valid claim under this warranty is received by ARI within the Warranty Period, ARI will, at its discretion, either (i) repair the defect without charge; (ii) replace the Product with a product that is at least functionally equivalent to the original Product; or (iii) refund the original purchase price of the Product. A replacement Product or part thereof, which has been installed in accordance with instructions (written and/or oral) provided by ARI, shall assume the remaining Warranty Period of the original Product. When a Product or a part thereof is replaced, any replacement item becomes the Original Purchaser's property and the replaced Product or part thereof becomes the property of ARI. When a refund is offered by ARI, such refund shall be conditioned upon the return of the defective Product to ARI. This warranty does not extend to components, parts or raw materials used by ARI but manufactured by others, which shall only be to the extent warranted by such manufacturer's warranty.

ARI shall be released from all obligations under its warranty in the event (a) that the Product has been subjected to misuse, neglect, accident, other external causes or improper installation, or if repairs or modifications were made by service personnel not authorized by ARI; (b) that the Product was not installed and/or operated in accordance with all local fire codes and plumbing codes, ordinances and regulations or printed instructions provided; (c) damage caused by improper handling, conveying, packing and/or improper installation.

EXCEPT AS EXPRESSLY PROVIDED HEREIN, ARI DOES NOT MAKE AND HEREBY DISCLAIMS ANY EXPRESS OR IMPLIED WARRANTIES RELATING TO THE PRODUCT, INCLUDING BUT NOT LIMITED TO, MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE, OR ANY WARRANTIES THAT MIGHT ARISE FROM A COURSE OF DEALING, USAGE OR TRADE PRACTICE INCLUDING WITHOUT LIMITATION, INJURY TO PERSONS OR PROPERTY.

EXCEPT AS PROVIDED IN THIS WARRANTY AND TO THE FULL EXTENT PERMITTED BY LAW, ARI SHALL NOT BE RESPONSIBLE AND/OR LIABLE FOR DIRECT, SPECIAL, INCIDENTAL OR CONSEQUENTIAL DAMAGES OR LOSS RESULTING FROM ANY BREACH OF THE ABOVE WARRANTY OR UNDER ANY OTHER LEGAL THEORY.

PROOF OF PURCHASE

It is the responsibility of the Original Purchaser to establish the original purchase date for warranty purpose. We recommend that a bill of sale or some other appropriate payment record be kept for that purpose.
